Tearfund's life-changing Transforming Communities training, run through local churches, equips people to identify their needs and resources and turns hope for the future into reality.

This Bible-based training enables churches around the world to show God's love in action and bring lasting transformation through your legacy.



Whether it's through **co-operative farming, building schools, access to water,** or **helping people with alternative sources of income,** your gift will continue to change lives for generations to come.

Planting seeds of hope in Zimbabwe

Climate change is increasing the magnitude and frequency of droughts in Zimbabwe.
The prolonged dry spells and increased temperatures meant that severe drought left more than 6 million people in need of food aid in 2024.

However, hope is not lost.
After taking part in Tearfund's
Transforming Communities
training run through theirlocal
church, young people are setting
up organic gardens to boost
food production and contribute
towards reversing the impacts of
the climate crisis.

One area where gardens are being established is Mbire, a community in the north that regularly experiences unpredictable rainfall.

Following their training, the young people have moved towards drip irrigation, vertical gardening and planting small grains, saving space and water. It also adds beauty and character to the land, improves air quality, and increases

crop yields due to better air circulation and sunlight.

The young people have planted fruit trees including avocado, palm, guava, apple, peaches, mango, and orange. They have also grown different types of tomato, kale and maize.

And it doesn't stop there. The young people are sharing their knowledge of planting and water harvesting with the wider community, enabling more people to grow the food they need.

'The young people of Mbire are leading the change in their community,' says Idzai, Project Team Leader. 'Please pray for the Lord to stir more innovative ideas in the minds of our young people so they can address the food crisis.'

They've been empowered to shape their own future by identifying the God-given resources in and around them, improving their lives and the lives of their families for years to come.

Having a will in place gives peace of mind and makes sure that your family and loved ones are provided for, as well as giving you the opportunity to remember causes you care about.

If you're amending an existing will, we are immensely grateful that you'd consider including us within it. If you're making a will for the first time, it's simpler than you might think – and it can even be free.

We recommend that you have your will written by a solicitor or a qualified will writer who can guide you through the process to ensure that your wishes are correctly recorded.

Including gifts in your will

Step 1: Decide on the type of gift to Tearfund



Our will-writing partner organisations can help create or update your will for free, providing advice on your type of gift below. See the enclosed sheet for further details of our will-writing partners.

A residuary legacy

This is a share or percentage of your estate after other specific gifts and expenses have been made.



The great thing about this type of gift is that it won't be devalued by inflation.

A pecuniary legacy

This is specific sum of money, which you can ask your solicitor to index-link. This means that the number will then increase with inflation and cost-of-living changes, so that it remains an accurate representation of what you would like to give.



Remember, ask your solicitor to index-link this gift to safeguard its value!

Leaving something specific

Some people decide to leave **a particular item** such as property, shares or jewellery.

Step 2: Create or update your will



For your convenience, the templates below can be used to leave a gift in your will to Tearfund. These wordings ensure clarity and legality. Just fill in the blanks according to what you wish to gift.
